AgConnect

AgConnect is a web-based application for securely completing and submitting AgriStability program forms.

Eliminate paperwork and benefit from the AgriStability online filing system at no additional cost.

Secure and prompt filing.

Securely login into your client's AgConnect account and view or submit information at your convenience. You can also send supporting documents electronically on your client's behalf. Once submitted, these forms are loaded automatically into our system expediting SCIC's processing for your client.

Give your clients peace of mind.

When information is submitted through AgConnect, a confirmation email is sent to the participant stating the date the information was successfully submitted.

Easily access historical information.

With AgConnect, each participant's AgriStability information is electronically stored online allowing you (or your client) the ability to quickly and easily access information when needed. You can also view historical information, such as the annual Enrolment/Fee Notice or previous form submissions, for reference.

By filing AgriStability information through AgConnect, producers with operations classified as *Corporations, Co-operatives and Other Entities* have their information sent directly to Agriculture and Agri-Food Canada (AAFC) for AgriInvest. This eliminates manual data entry and saves both you and your client time!
