IMPORTANT:

How to Complete your Stored **Grain Declaration**

 Stored grain not previously reported will be considered new production in the event of a yield-loss claim.

If your production is mixed with that of any other producer, either in sales or storage, yieldloss claims will be pro-rated (averaged among individual producers).

All stored grain, whether the crop is insured in the current year or not, should be reported.

1 Select the unit of measure you are using to report amounts.

- 2 List the crop name or code of the grain in storage. For example, Hard Red Spring Wheat or 001. Crop codes are listed in the Insurable Crops Identification Sheet available on www.scic.ca under Program
- Provide the gross amount of grain in storage.
- 4 Provide the amount that is intended to be sold prior to this year's harvest.
- 5 Provide the amount that is intended to be fed prior to harvest.
- 6 Will stored grain be covered with new production?
- Customer signature and date completed.

Remember to Update your Unproductive Land

List the number of acres considered unproductive; cultivated acres that are not in condition to be seeded and not eligible for an unseeded acreage claim.

This also applies to land that was cultivated at one time but is not seeded or put into a seedable condition. Unseeded acreage claim premiums are not charged on acres considered unproductive.

Your Seeded Acreage Report Checklist

- Have you included all acres and land that you own and operate in this report (insured and uninsured)?
- Do your reported acres match your total cultivated acres?
- Have you accurately reported acres intended for summerfallow?
- Have you accurately reported seeded acres that are eligible for summerfallow coverage?
- Have you reported all underseeded acres?
- Have you reported your crop varieties and seeding dates?
- Have you reported all of your acres too wet to seed?

Seeded Acreage Report

You must submit a Seeded Acreage Report declaring your seeded acres no later than June 25. This report is necessary to calculate your level of insurance and process your claims.

You do not have any Crop Insurance coverage until you report your acres on your Seeded Acreage Report. If you suffer a crop loss and have not reported your acres, your claim may be denied.

You can phone, email, fax, mail or drop off your seeded acreage information at any SCIC office, or CropConnect customers can complete personalized reports online.

Establishment Benefit Claims

Crops that do not grow or adequately establish may qualify for a payment.

File your claim before June 20.

If you believe you need to reseed or work down a portion of your crop prior to June 20, contact SCIC immediately before reseeding or destroying the acres.

How to Complete your Seeded Acreage Report

Note:

- All land owned and operated must be listed.
- Land additions or deletions should be made as soon as you are aware of the change. Crops on these additional acres must have been endorsed by March 31 to be insurable.

- All land changes are subject to approval.
- Land changes may not be eligible for insurance if damage occurs before you notify SCIC.
- **1** Sign and date the form.
- 2 Select this box if you would like to volunteer yields on uninsured forage crops. This information can be used to establish individual yield history for future forage insurance coverage.

- List seeded acres as summerfallow (SMF), stubble (STB) or irrigated (IRR) beside the land location and under the crop that is seeded.

- 16 Total seeded acres per crop per page.
- 17 Last seeding date per crop.
- B The grand total of acres (listed on the last Seeded Acreage Report page).
- 19 List the number of acres of unproductive land. Cross out any preprinted unproductive acres that were summerfallowed or seeded. If the acres are seedable adjust the acres in the unproductive column.

Unseeded Acres

If the weather isn't cooperating with your farming plans, reach out to your local SCIC office to discuss your options.

The Unseeded Acreage (USA) feature is included with multi-peril coverage and is designed to compensate producers who are **unable to seed due to excess spring moisture**.

Acres subject to flooding, such as sloughs in the field, that are traditionally wet or remain underwater in a year of normal moisture are not eligible. All USA claim acres are subject to inspection.

Claims must be requested by June 25.

√cropconnect

CropConnect gives you the flexibility to identify and report your acres the same way you farm. You can organize and report your acres by adding field names, linking multiple fields together or splitting fields.
